- Wheelchair shipments that are not more than one, are exempt from customs, are not transported for commercial purposes and when the consignee is not arranged as a legal entity in the bill of lading, these shipments are exempted from the above tariffs upon instruction of the Disability Health Board Report.
- AVI care fees are applied for pets (PET) upon customer request and in cases of necessity.
